5. News/Updates from Working Groups, Staff and Council

5.1 Accessibility Officer Update

B. Condie provided the following overview of the Accessibility Forum to be held at Fleming College on Wednesday, October 23rd:

- There are 145 registered attendees for the Forum;
- Fleming College has an accessible entrance for individuals with mobility issues; B. Condie outlined where the accessible entrance is located;
- Fleming College students will be on hand to assist attendees with accessibility issues on the day of the Forum;
- The Forum has been advertised through an on air interview with Bob FM as well as through a written article in the Lindsay Advocate;
- Registration for the Forum has now closed and attendance numbers have been given to the caterers so arrangements can be made for refreshments and lunch;
- Highlights from the Forum will be posted on the City's website following the event.

5.2 Public Awareness (Public Education/Employment/Information and Communication)

There was no update from this Working Group.

5.3 Public Spaces (Parks, Built Environment and Transportation (Transit))

N. Price provided an update on the following items:

- A meeting was held in relation to the new consolidated rural zoning by-law task force; comments have been sent to planning;
- Staff are proposing that the City's Transit Advisory Board amalgamate with the Public Spaces Working Group of the Accessibility Advisory Committee. A report will be presented to Council in November in this regard. Councillor's O'Reilly and Richardson, formerly of the Transit Advisory Board, have indicated that they would be willing to attend Public Spaces Working Group Meetings, as schedules permit;
- N. Price questioned if transit routes/stops are being contemplated for the proposed housing development located at Colborne Street and Highway 35 in Lindsay; B. Condie confirmed that transit would be taken into account during the planning process.
