The component of this item was: "**That** the linkage route for ATV's through the urban area of Lindsay proposed by the Off Road Vehicle Use of City Roads Task Force not be approved"

Council voted to eliminate that part of the recommendation from the modified motion set forth by Pat Dunn, when that part of the motion was in fact the key issue discussed at the Committee of the Whole. Kudos to Pat Dunn for this sly maneuvering, but Mr Mayor and Council, please don't lose sight of the fact that 66.4% of those responding to the survey said NO TO ATVS ON LINDSAY STREETS"

I Would hope that one of you councillors would re-introduce a motion at the next Committee of the Whole to cover the removed clause: That the linkage route for ATV's through the urban area of Lindsay proposed by the Off Road Vehicle Use of City Roads Task Force not be approve.

I have no idea why Pat Dunn is so bound and determined to get a road access through Lindsay when he hasn't taken the time to go door to door and ask his constituents what they feel about his recommendation, after all, these are the people who will either vote for him in November or

vote for anyone else to runs against him. When Pat Dunn was asked what his constituent wanted, his reply was "I have no idea". Instead, he continues to cozy up to KATVA, I wonder what the driving force there could really be.

Not sure how many of you got a chance to look at the ORV Task Force meeting video, but it's obvious that the Task Force has one objective in mind. That is to open all roads in the CKL to the ATV crowd.

At one point in that meeting Councillor Richardson admitted that residence in her ward and also Councillor Ashmore's ward are already flaunty the current by-laws and riding their units on area roads.

I actually saw this 1<sup>st</sup> hand in Omemee on Saturday Sept 11, 2021, with someone who admitted to me he didn't have a drivers license and when I looked at his unit it didn't have a license plate so obviously he would have insurance. This gentlemen got on his unit rode to Mary Street West and than turned right onto Hwy 7 and headed east on Hwy 7.

Is the council going to reward these ATV users for bad behaviour.

Councillor Dunn stresses that it's only a 2 year trial period, but lets all be honest with each other. The trail period will never be reviewed and we will just open up the CKL south of HWY 8 to all ATV users. How about we try this: have a 2 year trail period as it is and provided there are no reported infractions of the current by-law or accidents in the area, then we reconsider whether to open roads for ATV riders.

In my opinion Mr Stuart Bothwell had it right, it's time to cancel the ATV Task Force and stop wasting CKL resources.

One last point, did you notice that the 2 new members of the Task Force are also ATV users, I am sure that goes against the instructions issue by council on June 14,2021, but is another example of Pat Dunn's push to have ATVs on city streets. Dear Councillor Dunn -

I watched Tuesday's meeting and I'm sorry but you are not listening to your constituents. The people of Lindsay do NOT want an ATV route through town. The reason only 700 people are against it is because not enough people knew about the survey - it wasn't advertised well. In addition, many people don't know how to go online and fill out the survey - myself included (a flimsy two question survey is also not sufficient.) I have lived in Lindsay for 40 years and not one person I know wants a route through Lindsay and your continued passion and desire for this is difficult to understand. The idea is ridiculous and the argument for a bolstered economy is preposterous. People who are riding an ATV are not going to take off sweaty helmets and dusty outfits to go shopping or out to eat. Really? And put the stuff they've purchased where? It is absolutely ridiculous and your continued voraciousness for this cause is insulting to the people who vote for you. I know many, many people who are considering not voting for you again since you seem so reluctant to listen to the wishes of people who vote.

Do better. Let go of this unwanted and unliked proposition. You know people don't want this - so many individuals have come to council against this so listen to them - and frankly, watching council spend so much time and money on this is beyond frustrating.

Dear Councillor Dunn,

I am writing to commend you and your colleagues for council's decision to step down from the proposed ATV trial route through Lindsay.

Over the past four decades, as a provincial conservation officer (retired), I have operated all-terrain vehicles of all varieties and in almost every operating environment imaginable, ranging from rugged terrain to skidder trails, and from frozen lakes to forest access roads. I have likely logged more on-machine hours than most recreational riders will ever accumulate. In addition to being an operator in a professional capacity I have also been a Canada Safety Council All-Terrain Vehicle Operator Instructor and have provided ATV training to many of the conservation officers currently in the field.

Based on my experience, my observations of other operators, and my professional training I can unequivocally say that operating an ATV on any hard surface, especially on a paved roadway, is inherently unsafe for the operator. The short wheel-base, the narrow wheel-stance, the low pressure tires and the high center of gravity that makes these machines effective in off-road environments also makes them unstable, and prone to crabbing and roll over, when operated on hard packed surfaces.

By keeping these machines off Lindsay streets you are undoubtedly saving ATV operators and pedestrians from serious injury or even death.



The official City authorized petition that my wife and I worked extremely hard on and submitted in good faith to Council stated:

 We, the undersigned, petition the Council of the City of Kawartha Lakes to maintain the status quo, and to make no changes to Bylaw 2019-077 which would allow ATVs on the proposed route or any municipal roads in Lindsay for a pilot program or permanently.


There are 847 signatures on a City authorized petition that do not support a "pilot program" or a route through Lindsay. The petition was signed by residents all over Lindsay.

### **Lindsay Residents Petition**




Council's own survey, which was directed at residents of Lindsay, asked two simple questions: "Do you live in Lindsay?" and "Are you in Favour of having a route in Lindsay to connect the trail heads?" Overwhelming 66.4% of Lindsay residents, 717/1080, said NO to an ATV route through Lindsay.

In contrast, 105 Lindsay residents responded to the ORV Survey conducted by the ORV Task Force, in March 2021. The survey was very heavily promoted to ATV owners and KATVA members through their membership, Facebook and affiliate groups. Not surprisingly, most respondents were NOT from Lindsay, most were ATV owners, and some were from outside Kawartha Lakes.

# **ORV Task Force Survey March 2021**



There have been countless deputations to Council and the ORV Task Force opposing an ATV route through Lindsay.

The ORV Task Force could have ensured that those in Lindsay, particularly those within 120m of any ATV route, were sent notice like the City does with planning notices - a level of consultation and due diligence that residents would have appreciated.

KATVA members, 2500 out of a population of 75,000, are a small percentage of the entire Kawartha Lakes population and most live outside of Lindsay.

Combining two entirely different surveys, which ask different questions – one targeted at Lindsay residents, and another which was heavily promoted by KATVA is not a number which has any meaning.

If KATVA wanted to show that Lindsay residents wanted an ATV route, they too could have done a City sanctioned petition, and they did not.

The City's survey response and the residents' City authorized petition results were extremely high.

Ignoring the Lindsay residents' input and the professional advice the ORV Task Force and Council have been given, undermines the public's trust in decision making.

An overwhelming majority of Lindsay residents, 66.4%, 717/1080, in a survey conducted by Council, do not support an ATV route in Lindsay.

In addition, 847 Lindsay residents who signed the City authorized resident's petition do NOT support a **permanent**, **or pilot** ATV route through Lindsay.

With in 3 days we had over 60 bikes registered to join us on the ride (we had to close registration and are now turning people away). This means 60 bikes heading up to Kinmount for lunch, to shop, and to enjoy our trails. If Lindsay had a trail system allowing entry into down town Lindsay we may have changed our route to include that instead.

60 bikes that's one ride. That's a significant amount of tourist money going to a small town. Much needed money for the small businesses in lindsay that are struggling after the pandemic.

Let the Pilot Project run, what do you have to lose?

In the 1960's, Leslie Frost said that Lindsay would not allow GM into his tourist town. In the 2000's the Town Council voted against big box stores such as Walmart and instead that site is being developed for housing, which most current residents won't be able to afford. These residents need to travel to Oshawa, Peterborough or beyond for work as there is NO work in Lindsay.

So, for 50+ years the Lindsay Town Council has remained steadfast that Lindsay is a Tourist Town, but has NOT allowed ATVs within town for residents or tourists to connect to all established trails and to take advantage of all that Lindsay has to offer.

Please respect the outcome of this survey to finally put to bed any misguided notion of allowing additional ATV/OTV use on CKL roads.

Again, I was appalled that during the last ATV/ORV Task Force the Task Force acknowledged that ATV/ORV users are running on streets that are closed to them and the Task Force appears to think that's OK and are willing to award this flagrant violation of CKL By-Laws by opening up more roads in the area.

Anything that promotes outdoor activities and mental health should be green-lit as far as I'm concerned.

This trial project is just that - a trial - what's to lose? From what I understand, the majority of those canvassed are in agreement. Fenelon Fall's is a great example of how this can work, so why not *try* it out here for a beat?

This isn't about safety as the opposition would tell you. We all know the examples they use are skewed and mis-leading. If we were talking about safety, we'd be cracking down on e-bikes jumping from sidewalk to road and back with un-licensed and un-insured riders (often riding without safety gear). We are all licensed and insured, pay our yearly dues and ride within the rules of the trail.

This is about quality time with friends and family. It's about country living and the great outdoors. I'm not looking to ride 80km/h down Kent, I'm looking to get through Lindsay and pickup snacks,

gas, stop for lunch and maybe do some shopping. I'm looking to expand our riding region and have further family adventures. Our extended family all from around Northern Ontario rides, and have trailered their machines down here many times and picked up a day pass to ride.. this is tourism money with a license to print.

This is about listening to all of your taxpaying constituents and residents and business owners who want this too. The majority of CKL has said yes - why are you continuing to have a circular conversation purporting to represent a base that has already spoken in favour of the thing you're discussing? I honestly can't wrap my head around it.

I certainly hope you represent the majority in the next stage of this, and launch this trial project.

For anyone who has not experienced the exhilaration and thrill of riding through the trails of the Kawartha's and enjoyed the nature and scenery, they would certainly not understand the social and mental benefits that these outings bring to individuals and their well-being.

My name is Greg Lawrence and I purchased a property in Cameron in November 2017 to use as a cottage for now, with the intention of eventually retiring there. I can honestly say that getting out on the trails and getting away from the hustle and bustle of Toronto is a welcome change and provides much needed stress relief while enjoying the sites and sounds of the outdoors.

More importantly, my 23 year old daughter lives at our cottage and is currently working 2 different jobs in Lindsay since graduating from the University of Guelph last year. She suffers from Anxiety, Depression and Social Anxiety disorder. She has been attending therapy since she was 12, and continues to see her regular therapist now, some 11 years later and although she has made significant progress, still experiences her depression.

One of the greatest therapeutic experiences she has, is going for a ride on our ATV, and a taking in the beauty and nature that the trails in the Kawartha's have to offer. To put aside the trials and tribulations of day to day challenges and clear her mind. We have hiked the trails, walked through Ken Reid Conservation Area and enjoyed all that nature can provide. In speaking with her therapist, I've been informed that this sole, and lone activity helps my daughter the most in overcoming and managing her illnesses. This is something that a trained professional cannot provide to a patient, and can also reap the greatest of rewards for those who need it the most.

While on a ride to the south towards Lindsay one day last year, she came across many butterflies and stopped to admire their beauty and activity. From there, she researched and learned of the declining population of the Monarch butterfly and the dangers that they face. She then contacted the Ministry of Natural Resources to see about obtaining a permit/license to 'breed' and repopulate the Monarch population and after several interviews and an application process, she was awarded with a permit to do just that. This year alone, she was able to produce over 30 Butterflies from an egg, to a caterpillar, to chrysalids, to healthy Monarchs. I invite all of you to visit Rachel Lawrence on Facebook and witness these amazing pictures and videos that she has posted. Nature and the outdoors can significantly benefit an individuals mental health.

I am respectfully asking all councillors to consider the expansion of ATV trails through the Lindsay area for the enjoyment of the great outdoors for ATV and nature enthusiasts, and to also consider the positive affects this can have on those who suffer from mental illnesses. ## **Good Morning**

It has been 2 years since I've owned an ATV and 5 years since moving to Lindsay from Durham Region. I don't normally take the time to voice my opinion about city issues but in this circumstance I felt the need to share my thoughts on the uses and benefits of having a designated path thru Lindsay joining the Kawartha trails.

I understand that until you become invested in a hobby you do not truly understand the benefits that go with it. My boyfriend and I decided to purchase 2 ATV's 2 years ago, this was an initial \$23,000 investment and it was purchased <u>locally</u>. After which we needed the membership, licensing fees and gear, i.e. helmets, gloves, communication system, etc. this was another \$1,000 per person investment. Then we needed to purchase a trailer to haul it from my home to the trail system, this was another \$5,000 purchase, done <u>locally</u>. So just in the first month after purchasing these 2 ATV's we have invested \$30,000 in the Kawartha Lakes local community.

So when I mentioned we became invested in this hobby, it really is an investment. Both of us work 2 jobs, are single parents and struggle in the best of times to find ways to enjoy life with minimal costs. The ATV's were a very large investment and a toy I truly never thought I would own but now being a rider I realize there are numerous benefits to owning one.

Over the past 2 winters, I have been able to use my ATV to clear my driveway and have been able to clear my neighbours as well who would not be able to clear it themselves (seniors). It is also a very useful piece of equipment around the rural properties that Kawartha Lakes boasts. We have also found that over the past 1 ½ years it has been a source of balance in our work and personal life and as essential workers a way to destress during COVID.

But no sooner did we purchase the ATV's did we realize that the trail system has a black out area thru Lindsay. What I find frustrating is I could jump on my ATV and ride over to Thunder Bridge Road in about 15 minutes to catch the trail to Fenelon Falls but with the black out, I have to load up the trailer with 2 machines then drive over to Thunder Bridge Road, then unload them and head to the trail which takes about 40 minutes. So a quick ride up to Fenelon Falls on a Friday night to go for dinner sometimes is not possible due to the time constraints.

We have now rode the trails for 2 full seasons and we ride right up to Dec 1 when the trail closes. We have never seen anyone who is not respectful of other ATV riders, people walking on the trails, animals, bicyclist, etc. We never see anyone disrespecting the trails with garbage, loud music or destruction of the trails. The KATVA team also rides and checks ATV riders to validate they have the permissions to be on the trails and to monitor their respectful riding.

Having this alternate path thru Lindsay and removing the black out would enable us to jump on the ATV's and take a ride up to Fenelon and take in the water, shopping, food and community and keep our dollars spent in the Kawartha Lakes area.

As far as this 2 year pilot project, I find it frustrating that people that have never owned an ATV or maybe even been on one of the trails, have a negative opinion about something they presume will happen. How can you make a solid decision without solid data. This 2 year pilot project will enable both riders and residents in Kawartha Lakes to see how and if this path through Kawartha Lakes may impact them or not.

All riders hold Class G driver's licenses and have to be 16 years of age to ride or older. Most people we see on the trails are between 35-55 years old, all very established drivers and license holders. Our only focus is to get out, enjoy the day and get home safe.

I would ask that you vote in favour of this 2 year pilot project in order to better assess the uses, the users and their respect of this path and convenience through Lindsay and lastly, to be able to quantify any future decisions on real data before dismissing this plan.

We are all looking for the same thing; Safety on the roads, safety on the ATV's and cohesion with the community. What better way to bring the community together then enjoying it for its full uses and investing further in the businesses we all want to enjoy.

Good morning everyone.

I'm at a loss to understand how and why Council voted last week to approve the route through Lindsay.

Even more perplexing is why Councillor Yeo would change his vote, after all he was the one who tabled a motion in September not allow ATVs through Lindsay and to have the Task Force investigate an alternate route around Lindsay.

Just to review:

- 1) At the June Council meeting the route through Lindsay was proposed to Council. Rather than approving the recommendation, Council passed a motion to conduct a survey to determine what the residents felt about ATV going through Lindsay.
- 2) The residence were clear, 66.4% of respondents said they didn't want ATV on Lindsay Streets. No matter how Pat Dunn spins the numbers, the majority of respondents, 66.4%, said NO TO ATV ON LINDSAY STREETS.
- 3) As a result of this survey, Councillor Yeo tabled a motion at the Sept. Committee of the Whole to not allow ATV on Lindsay Streets, and for the ATV Task Force to investigate a route around Lindsay, this motion was approved.
- 4) At the Sept Council meeting, Councillor Dunn recommended that Councillor Yeo's motion be modified to only instruct the ATV Task Force to investigate a route around Lindsay. This motion was also approved.
- 5) At the ATV Task Force meeting, the group didn't take any action on the instructions of Council, but decided to present a 2009 report to council rather that doing what they were instructed to do. This is just another example of the contempt Pat Dunn has for his fellow Councillors and the residents of Lindsay.

My point here is that the instructions given to The ATV Task Force and Councillor Dunn, ,Seymour Fagan & Richardson was to investigate an alternate route around Lindsay. Suggesting a 2009 report fulfills their responsibilities under this motion again reflects the contempt these three councillors have for their fellow councillors and the residents of Lindsay. Until a proper investigation is made into an alternate routes around Lindsay, the vote on the June proposal should be ruled null and void as the investigation of the alternate route must be completed and presented to council before any other motion can be reviewed, after all the route through Lindsay was not approved in June, but was replaced by the requirement for a survey and subsequently the requirement to investigate an alternate route.

A lot of stock has been put into the fact that council received 145 emails last weekend in favour of a route through Lindsay. Has anyone taken the time to verify that the emails are from residents of Lindsay? More likely a close review with show a large percentage are from outside not only

Lindsay but also the CKL. How do these 145 suspect emails take precedence over 847 residence of Lindsay who signed a petition and the 66.4% on survey respondents to your survey that said NO TO ATV ON LINDSAY STREETS

Councillors, you have heard what the people of Lindsay want, we expect more from you than just bowing to a special interest group like the KATVA.

You all need to correct the error made on Oct 19, 2021 and rescind that vote until a current investigation of alternate routes around Lindsay is conducted and it is tied into the Trail Master Plan.

We quite often have ATVs entering our community of Southview Estates from outside areas. I am quite often at the Fenelon Falls museum tending gardens in the summer and every time I am there, ATV drivers are disregarding the signs designating the proper travel route, trying to cross the trail bridge, which is closed to allow boat traffic through the canal, or driving across the Garnet Graham Park lawn to get to the boat ramp road.

I'm certain that most ATV'rs try to follow the rules, but there are always those who believe that rules don't apply to them and will continue to practice their disrespect for rules, road signs, private property and people's right to peace and quiet, which cause problems for everyone.

It is evident, in my travels, that the further outside of Lindsay I travel, the less ATV'rs follow any sort of road rules and I have had to take precautions to avoid them on public roads, because the vehicles are loud and the drivers can't hear me behind them.

I understand that the plan for linking trails for ORVs will include expanded access to streets on the island of Bobcaygeon. I object to any expansion of road use for ORVs for several reasons;

To Task Force Members,

We've just looked at the upcoming report on a two-year pilot for expanding on-road ATV use in the City and are concerned for a number of reasons.

1. This is a **safety concern** in the communities involved and for anyone visiting them. Our own health unit cautioned against on-road use of ATVs because of the real potential for higher rates of injuries.

Studies of this are hard to find, but the University of Iowa specifically looked at ATV use on the road and concluded it was a serious traffic and public safety concern.

"Overall, our data reinforce the importance of laws restricting ATV road use and the need for effective enforcement, as well as the need to increase user education about ATV road-use laws and the dangers of riding on the roads."

The Consumer Product Safety Commission in the US looks at ATV deaths and has found that 65% of deaths were from on-road ATV accidents.

ATV manufacturers themselves caution against their use on roads, obviously for good reason. By approving on-road use of ATVs in CKL council is sending a confusing message about what constitutes safe riding practices.

2. In the category of if you build it they will come, we are concerned that opening the proposed areas to on-road ATV use will encourage much more ATV traffic, and thus not only more accidents, but also more emissions.

The UN's major climate conference just wrapped up in Glasgow and has shown us that we all need to do everything we can to improve climate outcomes for our kids. Encouraging emissions in a time of a climate emergency is going in the opposite direction.

We encourage you to follow the goals of the Kawartha Lakes Healthy Environment Plan to cut emissions by voting "No" to expanding the use of ATVs on roads in the City of the Kawartha Lakes.

**Subject:** Proposed Omemee Routes

Hi Pat + Task Force,

I've been following the workings of the ORV task force for some time now and I've been really impressed with all your effort and work. It's clear to me Omemee residents are very supportive of the pilot project, myself included. It was great to hear this support has been communicated by Omemee residents at the Special Committee of the Whole meeting today and to see that support was translated into a well received route connection for Omemee.

I was curious if any consideration was made for an additional connection via Sibley St as well as Sturgeon?

There's definitely a high volume of ATV users in the West end of Omemee around the Sarah Crescent area who would benefit from route access in their area. Whether intentional or not, I would expect that people living close to the approved routes would frequently make access via the quieter internal streets in town. It's certainly not abnormal to see ATV's on the internal streets of Omemee already and the community does a good job at self policing this practice.

The only issue I observe as a resident is when the Trans Canada Trail is being improperly used by ORV's. That practice is frustrating, as it negatively impacts the image of all ORV owners. From what I observe, this is done typically by folks on the East end of town traveling over to use some of the property around the Sarah Crescent subdivision area for recreational ORV use. Currently, the only connection West side of town has to Sturgeon St via public roads in town is Highway 7, as the town is essentially broken in two parts when removing Hwy 7 from the road map.

I think there's two benefits to considering Sibley St as part of the approved route.

- 1) The folks in the West side of town may more readily access an approved route to the VRT and would be much less motivated to travel to Sturgeon illegally along Hwy 7.
- 2) The folks on the east side of town who want to access the West side of town are able to do so without improperly using the Trans Canada Trail.

I attached a map here, which shows the interior streets of Omemee in blue, and the Trans Canada Trail and property frequently accessed in green.

I appreciate that on November 16, 2021 the Mayor and several Councillors identified safety and enforcement issues on several routes that are being considered. As a result, routes in Cameron and Bobcaygeon were excluded.

Has the safety review been done on any roads as promised by the ATV Task Force? The same issues mentioned at the November 16 meeting apply to other routes as well. Please consider the following for all routes:

- Exclusion of roads/sections with safety concerns
- A safety review of all routes before approval by Council
- A public meeting, after the holidays, where residents are not limited to 5 deputations or signing up the Friday before.

In addition, the 2-year pilot needs to include:

- Signage: identify permitted and prohibited routes, contact agencies and numbers to file reports
- Criteria: track complaints, collisions, accidents, ER and hospitalizations, charges, costs
- Enforcement: include provisions for pro-active and timely responses to outlying areas
- Education and public safety program: by the municipality in co-operation with bylaw and police enforcement
- Set timeline for Report back to Council and Notice to stakeholders

Respectfully, it's hard to believe that Council would pass an ATV route through Lindsay, and potentially allow ATV access to more CKL roads at the next Council meeting given the City's known and admitted issues for maintaining their roads. Even more alarming is that CKL has one of the lowest household per kilometre ratios to cover maintenance costs as well. ATV use on our roads is only going to increase maintenance costs within a City that has a hard time finding the money to manage their roads. This potentially large additional cost to the taxpayers that will inevitably make our roads worse within CKL is irresponsible.

I can appreciate that you all have a tough job being members of Council, but I thought this Council represented all of CKL residents? If it represents everyone within CKL, I thought this Council's strategic plan was to be fiscally responsible to all residents? Did the Councillor Yeo, Richardson, Ashmore, Dunn and Seymour-Fagan not know this information when they passed a route through Lindsay? If you truly represented all residents in CKL and not just those who ride an ATV, these statistics alone (in addition to Lindsay residents and the Health Unit saying "No" to an ATV route or pilot program) would have easily directed you to say "No" to ATVs on any CKL roads because it's fiscally irresponsible.

I again urge you to vote "No" to the additional rural routes proposed in areas within CKL at the next Council meeting, and reverse the decision for the route in Lindsay, so that ALL Lindsay residents' tax dollars can go towards the maintenance of roads with vehicles actually designed for the roads within a City that already has a tough time maintaining those roads.

If the Mayor and Council decide to not listen to the overwhelming evidence for "No" ATVs on rural roads along with reversing their decision in Lindsay, I must formally request that the following items be part of the process and included to monitor the pilot program along with being approved at the next ORV task force meeting on November 26th.

As quoted by Councillor Dunn at the last meeting and via the Jump In Site Communication email - Councillor Dunn, Chair of the Off Road Vehicle Task Force, made note that the Task Force will meet again on November 26 to discuss the process to monitor the success of the 2022 pilot programs. The meeting will begin at 10am and will be livestreamed on the <a href="municipality's YouTube">municipality's YouTube</a> channel.

The Pilot Program needs to include:

- What is the specific number of bylaw/police violation complaints, injuries or deaths that must be submitted that will revoke the pilot project immediately
- Signage: identify permitted and prohibited routes, important information for agencies and the specific contact information to file complaints
- who will be track complaints, collisions, accidents, ER and hospitalizations, charges, costs to City through maintenance and insurance
- who will be writing the report and tracking and maintaining the data from ATV incidents, injuries and deaths
- Enforcement: include provisions for pro-active and timely responses to outlying rural areas that are already proven hard to enforce.
- Education and public safety program: Created by the municipality in co-operation with bylaw and police enforcement
- Set timeline for Report back to Council and Notice to stakeholders ORV pilot stakeholder committee - which includes a representative membership from other sectors not just the ATV sector
- An official survey of the town and rural residents affected by the pilot program at year 1 for feedback

# What has Council done about the condition of roads?

Council has made significant strides toward improving roads over the last four years, investing \$72 million to maintain and update almost 700 km of roads throughout the municipality, including urban and rural roads.

Stover pointed out that although resident complaints tend to focus on road maintenance, the municipality has a sparse population supporting the vast network of roads (5,300km). This equates to the drive to Florida and back each time the roads are treated. There are seven households contributing to every kilometre of road maintenance in Kawartha Lakes, compared to 37 households in Peterborough and 80 households in Toronto. The sheer size of the municipality together with a predominantly rural population contributes to ongoing challenges with roads.
